CREDIT TERMS AND AGREEMENTS

This is an Application and Agreement for credit and shall apply to any and all credit extended by **GARDEWINE GROUP LIMITED PARTNERSHIP**. The credit applicant understands and agrees to the following terms and conditions of sale:

- 1. Terms of sale are net 30 days on approved credit or otherwise stated.
 - 1. a) Interest will be charged at the rate of 2% per month (24% per annum) on overdue accounts commencing on the 1st day that the applicants account is overdue.
- 2. All claims against invoices must be made within 30 days after receipt of service. Any dispute by the applicant shall be reported in writing to the Credit Manager of *GARDEWINE GROUP LIMITED PARTNERSHIP* within -30 days of the date that the labor was performed and/or the material was supplied, and the details of the dispute. If the applicant does not issue a written dispute within the said -30 days, not withstanding that the dispute is not resolved, the applicant shall pay to *GARDEWINE GROUP LIMITED PARTNERSHIP* all amounts due and owing, without any set-off pending resolution of the dispute. The payment made by the applicant shall not affect the applicant's dispute.
- 3. NSF cheques will be subject to a \$25.00 charge.
- 4. Applicant agrees to bear all costs incurred in collecting any unpaid amounts including but not limited to collection suit fees, legal fees and court costs.
- 5. The information given in this Application and Agreement is warranted to be true and correct and given for the purpose of obtaining credit.
- 6. The applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit reporting agency or to any person with whom the applicant has or proposes to have financial relations.
- 7. Upon determination that customer's creditworthiness has changed adversely or does not satisfy current credit standards, **GARDEWINE GROUP LIMITED PARTNERSHIP** may close or lower the credit limit of the account.
- 8. The applicant or applicants hereby agree that where there is more than one party to this agreement they shall be jointly and severally liable in the event of default hereunder.
- 9. The Owner is obligated to notify GARDEWINE GROUP LIMITED PARTNERSHIP in writing of any changes in ownership.
- 10. The applicant grants to **GARDEWINE GROUP LIMITED PARTNERSHIP** a security interest in all property under care and control of **GARDEWINE GROUP LIMITED PARTNERSHIP'S** possession until such time that all amounts owing by the applicant to **GARDEWINE GROUP LIMITED PARTNERSHIP** are paid.

PRIVACY POLICY

The *Act* does not apply to personal employment information which could identify the name, title, business address or telephone number of an employee of an organization, but this information will not be disclosed by **GARDEWINE GROUP LIMITED PARTNERSHIP** without your consent or as required by law.

"Personally identifying information" is information that can be explicitly used to identify and/or contact you as an individual. This includes information such as your real name, e-mail address, mailing address, phone number, credit card number, etc. Information that, by itself, cannot be explicitly linked with your "real" identity is not considered personally identifying.
